Privacy Policy

As a mandatory requirement of the Australian Privacy Policy Principles (APP) guidelines, under the Privacy Act 1988 (Privacy Act), the BiORG Privacy Policy explains how BiORG handles the personal information of its employees. BiORG Pty Ltd is committed to protecting your privacy and complying with the Privacy Act and other applicable privacy laws and regulations.

This Privacy Policy (Policy) describes how we collect, hold, use and disclose your personal information, and how we maintain the quality and security of your personal information.

What is personal information?

"Personal information" means any information or opinion, whether true or not, and whether recorded in a material form or not, about an identified individual or an individual who is reasonably identifiable. In general terms, this includes information or an opinion that personally identifies you either directly (e.g. your name) or indirectly.

What personal information do we collect?

The personal information we collect about you depends on the nature of your dealings with us or what you choose to share with us.

The personal information we collect about you may include:

- Name
- Residential address
- Date of birth
- Gender
- Email address
- Phone number
- Next of kin/Emergency Contact Details
- Defence personnel details
- Security Clearance Information
- Evidence of Qualifications
- Identity Confirmation Data
- Criminal History Data
- Pre-Employment information (tax file number, superannuation details etc)

Under certain circumstances, BiORG Pty Ltd may need to collect sensitive information about you. This might include any information or opinion, membership of a trade union or other professional body, criminal record or health information..

You do not have to provide us with your personal information. Where possible, we will give you the option to interact with us anonymously or by using a pseudonym. However, if you choose to deal with us in this way or choose not to provide us with your personal information, we may not be able to provide you with our services or otherwise interact with you.

How do we collect your personal information?

We collect your personal information directly from you when you:

- interact with us over the phone;
- interact with us in person;
- interact with us online;



- participate in surveys or questionnaires;
- attend a BiORG Pty Ltd event;
- subscribe to our mailing list;
- apply for a position with us as an employee, contractor or volunteer;
- apply to us as a client

Collecting personal information from third parties

We may also collect your personal information from third parties or through publicly available sources, for example from authorised partner including Cited (National Police Check) and AGSVA (Security Clearances). We collect your personal information from these third parties so that we may verify your identify, security clearance level or criminal history.

How do we use your personal information?

We use personal information for many purposes in connection with our functions and activities, including the following purposes:

- provide you with information or services that you request from us;
- deliver to you a more personalised experience and service offering;
- improve the quality of the services we offer;
- internal administrative purposes;
- marketing and research purposes; and
- recruitment and employment.

Disclosure of personal information to third parties

We may disclose your personal information to third parties in accordance with this Policy in circumstances where you would reasonably expect us to disclose your information. For example, we may disclose your personal information to:

- Business Partners, clients and other consulting firms we need to share reasonable personal information with our business partners, clients and some other consulting firms who we collaborate with.
- Our marketing providers from time to time we may share limited information for marketing purposes (for example: promoting BiORG Pty Ltd on LinkedIn).
- Professional services agencies as a consultancy we need to maintain and adhere to legal
 and industry guidelines this including background, police, and security checks to
 appropriate agencies.
- Our clients most of our clients have their own security measures, and we need to provide them personal information about our employee including background and police checks.

Transfer of personal information overseas

Some of the third-party service providers we disclose personal information to may be based in or have servers located outside of Australia.

Where we disclose your personal information to third parties overseas, we will take reasonable steps to ensure that data security and appropriate privacy practices are maintained. We will only disclose to overseas third parties if:

- you have given us your consent to disclose personal information to that third party; or
- we reasonably believe that:



- the overseas recipient is subject to a law or binding scheme that is, overall, substantially similar to the
- o APPs; and
- o the law or binding scheme can be enforced; or
- the disclosure is required or authorised by an Australian law or court / tribunal order.

How do we protect your personal information?

BiORG Pty Ltd will take reasonable steps to ensure that the personal information that we hold about you is kept confidential and secure, including by:

- having a robust physical security of our databases and records;
- taking measures to restrict access to only personnel who need that personal information to effectively provide services to you; and
- having technological measures in place.

Online activity

Cookies The BiORG Pty Ltd website uses cookies. A cookie is a small file of letters and numbers the website puts on your device if you allow it. These cookies recognise when your device has visited our website(s) before, so we can distinguish you from other users of the website. This improves your experience and the BiORG Pty Ltd website(s).

We do not use cookies to identify you, just to improve your experience on our website(s). If you do not wish to use the cookies, you can amend the settings on your internet browser so it will not automatically download cookies. However, if you remove or block cookies on your computer, please be aware that your browsing experience and our website's functionality may be affected.

Website analytics: Our website uses analytical services to help us better understand visitor traffic, so we can improve our services. Although this data is mostly anonymous, it is possible that under certain circumstances, we may connect it to you.

Direct marketing: We may send you direct marketing communications and information about our services, opportunities, or events that we consider may be of interest to you if you have requested or consented to receive such communications. These communications may be sent in various forms, including mail, SMS, social media and email, in accordance with applicable marketing laws, such as the Australian Spam Act 2003 (Cth). You consent to us sending you those direct marketing communications by any of those methods. If you indicate a preference for a method of communication, we will endeavour to use that method whenever practical to do so.

You may opt-out of receiving marketing communications from us at any time by emailing info@biorg.com.au, with please unsubscribe me in the subject line sent from the email address you wish to unsubscribe from.

Retention of personal information

We will not keep your personal information for longer than we need to. In most cases, this means that we will only retain your personal information for the duration of your relationship with us unless we are required to retain your personal information to comply with applicable laws, for example record-keeping obligations.



How to access and correct your personal information

BiORG Pty Ltd will endeavour to keep your personal information accurate, complete and up to date.

If you wish to make a request to access and / or correct the personal information we hold about you, you should make a request by contacting us and we will usually respond within 30 working days. We will deal with such a request by following the procedure outlined below:

- Acknowledgement of request
- Assess request in accordance with the Privacy Act 1988
- BiORG Pty Ltd will inform on change status or request access to requested information with a 30 day period or where it is considered a reasonable time under the Act or;
- Given a written response explaining why access has not been granted under the Privacy Act.

Links to third party sites

BiORG Pty Ltd website(s) may contain links to websites operated by third parties. If you access a third party website through our website(s), personal information may be collected by that third party website. We make no representations or warranties in relation to the privacy practices of any third party provider or website and we are not responsible for the privacy policies or the content of any third party provider or website. Third party providers / websites are responsible for informing you about their own privacy practices and we encourage you to read their privacy policies.

Inquiries and complaints

If you are not satisfied with BiORG Pty Ltd's response to a complaint, you have the right to contact the Office of Australian Information Commissioner (at www.oaic.gov.au) to lodge a complaint.
